- 1. Traffic has risen slightly over as compared to September, military is flying again, so things are looking up.
- 2. Passenger terminal count continued to drop due to Bristow is no longer flying out of ARA.
- 3. Property on David Dubois Rd update: waiting on a letter from the FAA for approval to sell the property, DOTD had no objection. Dean Wattigny checking IPG on the buy back policy.
- 4. Update on ARFF location- waiting on payment to be made to Michael Baker to continue the design phase, waiting on letter of no objection from the State, and waiting on funding plan for the ARFF building.
- 5. Update on storm damages at ARA: quotes for the tower roof damaged were acquired but more damage was found by Ace Roofing, so that was submitted to IPG, and the roof damage at LMA has been repaired by tenant.
- 6. FAA Inspection update, with COVID all documents will be digitally uploaded instead and inspection will now be March 3rd, 2021.
- 7. Lease Application discussion: Mr. Songy requested from the commission to streamline leases based on the type of lease, as well as change the fee schedule. This will require further discussion.

8. Update on the CIP 2021-Generator purchases was not approved by the FAA for 2021, but would be approved in the next couple of years.
