- II. Roll Call: Ms. Copell
- III. The Opening Prayer was offered by: Mr. Romero

V. APPROVAL OF MINUTES:

On a motion by Mr. Migues, seconded by Mr. Lamperez, the minutes of the Regular Meeting on November 10th, 2020 were approved unanimously.

VIII. ANNOUNCEMENTS FROM THE CHAIRMAN:

- 1. Update on Fed Ex, they are working on getting paint to be back on schedule for 2021 and will carry into a full year.
- 2. Spoke on adding new tenants to ARA.

IX. ANNOUNCEMENTS FROM THE DIRECTOR:

- 1. Traffic count is down from 2019, but military operations are on the rise.
- 2. Passenger terminal count is at zero due to Bristow no longer here at ARA.
- 3. Working on getting answers from Bristow on Hangars 14 & 53.
- 4. Peppers Unlimited are due to sign their lease on Tuesday the 15th.
- 5. FAA Inspection update: uploading all documentation required for their review.
- 6. Mr. Norris added that Bristow's parking bumpers need to be picked up and for Mr. Wattigny to review Hangar #53 lease process for a potential client to take over.
- 7. Mr. Songy heard that SLCC flight school was closing and asking for a contact person to call and notified everyone that he knows someone who is interested in the building.

X. FINANCIAL REPORTS:

On a motion by Mr. Broussard and seconded by Mr. Migues, the financial reports were accepted as presented.

XI. ENGINEER'S REPORT:

- 1. Hangar #88 Lighting Upgrade, LED Pro reduced number of lights per location, so budget will be reduced.
 - 2. Reel light that was struct last year by lightning is giving problems.
 - 3. LMA tree removal, owners were identified and there is enough money in state budget to cover removal by Laperouse Contracting.
 - 4. ARFF Station update: 75% of plans need to be submitted before grant will be re-issued to see if it interferes with airspace.

 - *** I, Mr. Leblanc move to appoint Mr. Norris as Chairman, he accepts, seconded by Mr. Broussard. Motion carried. Mr. Migues motioned to close nominations, seconded by Mr. Lamperez, motion carried.
 - *** I, Mr. Leblanc move to appoint Mr. Migues as Vice-Chairman, he accepted. Motion carried. Mr. Migues motioned to close nominations, seconded by Mr. Lamperez, motion carried.
 - *** I, Mr. Broussard move to appoint Mr. Romero as Finance Chair, he accepts, seconded by Mr. Migues. Motion carried. Mr. Migues motioned to close nominations, seconded by Mr. Broussard, motion carried.
 - 3. Discuss and take action to urge FAA to finalize rules and policies regarding the enacted Noise Waiver Legislation along with retaining lobbying and advisory professionals to assist IPAA in that effort. On a motion by Mr. Leblanc and seconded by Mr. Broussard, the commission authorized the Chairman to negotiate fees with Adams & Reese up to \$5,000 a month. Motion carried.
