- 2. Discussed Funding Code Budget Adjustment for N. GA Taxilane Improvements. On a motion by Mr. Leblanc and seconded by Mr. Migues, the authority authorized the Director to adjust the Funding Code Budget Adjustment once passed by the Parish Council. Motion carried by a unanimous vote.
- 3. Mr. Bernard with AVEX, discussed the termination of the \$550.00 a month Tug Rental fee. On a motion by Mr. Leblanc and seconded by Mr. Migues, because the Tug as no residual value, the authority granted the termination of the fee. Motion carried by a unanimous vote.
- 4. Discussed advertising for On Call Consulting Services Contract. On a motion by Mr. Romero and seconded Mr. Lamperez, the authority authorized Mr. Songy to advertise for the On Call Consulting Services for IPAA. Motion carried by a unanimous vote.
- 5. Discussed authorizing the Director to sign the Coronavirus Response Grant in the amount of \$57,162.00. On a motion by Mr. Leblanc and seconded by Mr. Romero, the authority authorized Mr. Songy to sign the Coronavirus Response Grant. Motion carried by a unanimous vote.

Motion carried by a unanimous vote.
