- 2. LMA Inspection completed last week, results expected in a week. Congrats to the maintenance dept on a job well done maintaining LMA. Inspector elaborated that its one of the best kept in the Non-Federally funded airports he has seen.

3. ARA-FAA Inspection is June 9th, 2021...first physical inspection since Covid began.
