# IX. ANNOUNCEMENTS FROM THE DIRECTOR:

- 1. Traffic Operations are close to 2019 and confident that they will finish strong in 2021. Anticipating 2022 to be back to normal pre Covid.
- 2. Presented Mr. Kirk Harrison with a recognition plaque for the Grumman S-2 "Tracker" model he so generously built for ARA.
- 3. Acknowledged Mr. Emmet Carson as facilitator of the "Tracker" project and introduced Mr. Bud Forrest and Dick Spears as pilots that once flew this plane.

#### X. FINANCIAL REPORTS:

On a motion by Mr. Lamperez and seconded by Mr. Broussard, the financial reports were accepted as presented.

## XI. ENGINEER'S REPORT:

- 1. ARFF Building-Design phase will be 100% complete by mid December and bid packages will be complete but project will be put on hold until available funding is given,
- 2. Hangar 88-Bid packages are complete but the project is currently on hold awaiting Avex's availability of the hangar.
- 3. N. GA Taxiway Imp-Project is on hold due to concrete specifications not able to be met. Letters have been submitted from Baldwin and Port Aggregates explaining their hardships, these letters will be submitted to the FAA for request approval of a Modification of Standard.

On a motion by Mr. Broussard and seconded by Mr. Lamperez, nominated Mr. Damon Migues as Finance Chair for the 2022 Executive Committee. Motion carried by a unanimous vote.

Discuss and consider a budget adjustment in the amount of \$764.68 from line item 4670-543100-6520-0051 (R/M BLDG) to 4670-543400-6520-0051 (AV GAS) to cover the shortage in the purchase of Av Gas at LMA. On a motion by Mr. Broussard and seconded by Mr. Migues, the IPAA approved a budget adjustment in the amount of \$764.68 from line item 4670-543100-6520-0051 (R/M BLDG) to 4670-543400-6520-0051 (AV GAS) to cover the shortage in the purchase of Av Gas at LMA. Motion carried by a unanimous vote.

Discuss and consider a budget adjustment in the amount of \$2,000 from line item 4670-55100-6520-0052 (Maint Contracts) to 4670-543200-6520-0052 (R/M Equip) to cover the shortage in the purchase Airfield Lighting. On a motion by Mr. Migues and seconded by Mr. Broussard, the IPAA approved a budget adjustment in the amount of \$2,000 from line item 4670-55100-6520-0052 (Maint Contracts) to 4670-543200-6520-0052 (R/M Equip) to cover the shortage in the purchase Airfield Lighting. - 5. Discuss and consider a budget adjustment in the amount of \$4,000 from line item 4670-543300-6520-0002 (R/M Vehicle) to 4670-543200-6520-0002 (R/M Equip) to cover the shortage in the purchase of a radiator as well as having extra to get us through the end of the year. On a motion by Mr. Broussard and seconded by Mr. Lamperez, the IPAA approved a budget adjustment in the amount of \$4,000 from line item 4670-543300-6520-0002 (R/M Vehicle) to 4670-543200-6520-0002 (R/M Equip) to cover the shortage in the purchase of a radiator as well as having extra to get us through the end of the year. Motion carried by a unanimous vote.
- 6. Discuss and take action regarding extension of lease term of hangar and fuel farm acreage per request of Trend Aviation as a result of capital improvements placed thereon. On a motion by Mr. Migues and seconded by Mr. Broussard, the IPAA approved a 10 year lease extension as a result of capital improvements and the extension will expire in 2032. Motion carried by a unanimous vote.
  - 7. Discuss and consider amending the 2022 Airport Authority Fund Budget as listed below in the net amount: \$233,333 to recognize State Funding received for Hangar 88 Project funded through FP&C and appropriate expenditure line items in accordance with State defined budget allocation. Said project will reduce fund balance. Estimated fund balance is \$1,677.718 at 12/31/2022. On a motion by Mr. Migues and seconded by Mr. Broussard, the IPAA amended the 2022 Airport Authority Fund Budget as listed below, motion carried by a unanimous vote.
