#### **IBERIA PARISH AIRPORT AUTHORITY:**

1. Discuss and consider a budget adjustment in the amount of \$10,000 from line item 4670-533000-6520-0053 (PROFESSIONAL SERVICES/BLDG) to 4670-543400-6520-0051 (AV GAS) to cover the remaining future purchases of Av Gas at LMA in 2022. On a motion by Mr. Leblanc and seconded by Mr. Migues, the IPAA authorized the budget adjustment in the amount of \$10,000 from line item 4670-533000-6520-0053 (PROFESSIONAL SERVICES/BLDG) to 4670-543400-6520-0051 (AV GAS) to cover the remaining future purchases of Av Gas at LMA in 2022. Motion carried by a unanimous vote.

2. On motion by Mr. Migues seconded by Mr. Leblanc,

In the matter of Trend Aviation LLC leases the following actions are to be taken to clear up the confusion over the Trend leases, amendments and extensions:

- 1. The lease of February 1, 2012 with Trend Aviation, LLC and/or Trend Services, LLC for construction of a corporate hangar is to be cancelled by the parties as the leasehold was never occupied and the hangar never constructed. The lessee having assumed the lease on another hangar.
- 2. The August 4, 2014 agreement to provide for the additional tract of approximately .13 acres for lease to Trend Aviation, LLC at the additional beginning rent rate of \$3,386.00 subject to yearly CPI calculations shall be corrected so confirm the lease being amended as the October 16, 2009 lease assigned to Trend Aviation, LLC by High Capacity Coils, LLC of the .338 acre tract with hangar and not the February 1, 2012 Lease that is being cancelled.
- 3. The authority accepts the construction of the fuel farm on the .13 acre tract and in consideration of the value of the improvements extends the .13 acre tract lease to coincide with the term of October 16, 2009 lease so that the termination date of the amended leases are October 15, 2039.
- 4. The Chairman of the Authority is authorized to cancel and amended the leases in accordance herewith. Motion carried by unanimous vote.
- 3. Discuss and consider declaring the property on David Duboin Road to become surplus property, release to the IPG as well as releasing management from IPAA to IPG. On a motion by Mr. Leblanc and seconded by Mr. Migues, the IPAA declared the property on David Duboin Road surplus property, released it to the IPG as well as released management from IPAA to IPG.
