- 1. Traffic count is still down from 2021 due to fuel cost, but expecting more activity in 2023.

Discuss and consider amending the 2022 IPAA Fund Budget in the amount of \$1,496.800 to recognize the Federal and State funding received for the design and rehab construction services to be performed on the N. GA Taxiway (N. Connector) & appropriate said expenditures in accordance with the grant's defined budget allocation. Said projects are fully reimbursable and will have no effect on fund balance. On a motion by Mr. Broussard and seconded by Mr. Lamperez, IPAA amended the 2022 Fund budget as presented. Motion carried by a unanimous vote.
