Section and appropriate said expenditures in accordance with the grant's define budget allocation. Said project is fully reimbursable and will have no effect on fund balance. - 6. Discuss and take action on the two quotes that were submitted to Avex for gutter repairs. E&L Construction-Northside Gutter Project \$52,878.63, Southside \$42,931.47. Southern Constructors-Northside \$28,500.00, Southside \$22,900.00 to be paid from budget line item-Repair/Maintenance Buildings. On a motion by Mr. Broussard and seconded by Mr. Boudreaux, the IPPA awarded Southern Constructors to do all repairs as presented and to be paid from budget line item-Repair/Maintenance Buildings. Motion carried by a unanimous vote.

- 8. Discuss and consider amending the 2023 IPAA Fund Budget in the amount of \$5,000 to appropriate additional expenditure funding for the N GA Taxilane Imp. Project. From line item 4670-499000-0000-0000-0000/Fund Balance to 4670-533100-6520-1071/Arch/Eng Services. On a motion by Mr. Broussard and seconded by Mr. Migues, the IPAA approved as presented. Motion carried by a unanimous vote.
- 9. Discuss and take action the Offshore Energy Lease Application and authorize the Chairman to negotiate & sign a lease agreement. On a motion by Mr. Boudreaux and seconded by Mr. Migues, the IPAA authorized the Chairman to negotiate & sign a lease agreement with Offshore Energy. Motion carried by a unanimous vote.

Discuss and take action regarding the relocation of a gas pipeline in connection with Project USA-5, the method of funding said relocation, authorizing the Chairman to execute any agreements or other writings relating thereto, and take any other actions necessary to carry out the intent and purposes thereof. On a motion by Mr. Broussard and seconded by Mr. Boudreaux, the IPAA are in support of Project USA-5 and will take necessary action to explore all methods of financing to move said pipeline to accommodate the potential tenant.
