- 1. Discuss and take action on amending the IPAA Fund Budget in the amount of \$1,691,201 to appropriate funding needed for the construction services for Bulk Hangar-Construction Phase I Project, all to be funded from Federal Aviation Administration (FAA) Revenues (\$1,462,661) with balance (\$240,540) being funded from Department of Transportation and Development (DOTD) Aviation revenues. On a motion by Mr. Migues and seconded by Mr. Lamperez, the IPAA amended the Fund Budget as presented. Motion carried by a unanimous vote.
- 2. Discuss and take action on amending the IPAA Fund Budget in the amount of \$100,000 to appropriate funding needed for the engineering services for LeMaire Runway Overlay-Design Project, all to be funded from Department of Transportation and Development (DOTD) Aviation revenues (\$90,000) with balance (\$10,000) Fund Balance-Previous Years line item. On a motion by Mr. Broussard and seconded by Mr. Migues, the IPAA amended the Fund Budget as presented. Motion carried by a unanimous vote.

- 3. Discuss and consider authorizing the Chairman or Director to sign upcoming State Grants. On a motion by Mr. Migues and seconded by Mr. Lamperez, the IPAA authorized the Chairman or Director to sign upcoming State Grants. Motion carried by a unanimous vote.
- 4. Discuss and consider accepting the proposal from E.F. Thompson Geotechnologies, Inc. for the Compass Rose Calibration Pad at ARA, not to exceed \$30,000. On a motion by Mr. Lamperez and seconded by Mr. Migues, the IPAA accepted the proposal as presented. Motion carried by a unanimous vote.
- 5. Discuss and consider accepting Task Order #2 from Mead and Hunt for the East Side Development project at ARA. On a motion by Mr. Migues and seconded by Mr. Broussard, the IPAA accepted Task Order #2 as presented. Motion carried by a unanimous vote.
